Subject: Review of the New Constitution

1. Purpose of Report

1.1 To outline the proposal for the new constitution for examination and review.

2. Background

2.1 A key commitment of the administration is to modernise the Council and as part of that process to review the Council's Constitution.

3. Present Position

3.1 A refresh has been undertaken to review the council's decision-making arrangements.

3.2 This included a comprehensive examination of the existing Constitution. Detailed below is a comparison of the existing and proposed Constitution.

Next Steps

4.3 Following the initial briefing members of Scrutiny were invited to feed back to the Political groups and identify 'five bugbears' with the constitution which Members would wish to see addressed. This feedback will need to be incorporated in the review.

4.4 Financial Procedure Article 16 is under review by the Section 151 Officer.

4.5 Chapter 3 Codes and Schemes this will be circulated. Members are reminded that:

- The Member Code of Conduct - is unchanged.
- Members Allowances is to be reviewed for the new administration in May 2024.
- Improved guidance for gifts and hospitality.
- Improved clarity of Member/ Officer Protocol.

4.6 Chapter 4 Functions and Responsibilities contains Scheme of Delegations for Cabinet and the Office scheme of delegation which is being revised considering the new organisation.
