Subject: Appeal against refusal to grant a Private Hire Driver's Licence – Applicant S

Report of: Head of Licensing and Safer Communities

1. Purpose of Report

To consider the appeal made by Applicant S against the refusal by the Council to grant a Private Hire Driver's Licence.

2. Background

2.1 Applicant S previously held a Private Hire Drivers Licence with CPBC from 9 September 2019 to 17 August 2022.

That licence was revoked on 17 August 2022 after Application S provided false address information. Applicant S appealed that decision but it was upheld by a Licensing Sub Committee on 13 September 2022. Applicant S was advised that a brand new application could be considered one year after the date of revocation.

Applicant S submitted the new application on 17 August 2023. On the application he declared that he had the following new motoring conviction recorded on his driving licence since the revocation:

- 3 April 2022
CU80 – Breach of requirements as to control of the vehicle, mobile telephone etc
Penalty Points - 6

This conviction means Applicant S does not meet the CPBC Pre Licensing Conditions and the application was refused on 18 August 2023.

The driving licence summary is attached at Appendix 2

3. Castle Point Hackney Carriage and Private Hire Licensing Policy

3.1 Assessment of Previous Convictions

Guidance on assessment of previous convictions was contained within the Department for Transport's (DFT) Statutory Taxi and Private Hire Vehicle Standards released in July 2020. These standards were adopted by the Council in November 2020 following a period of consultation and include the following in relation to driving offences:

Offence	Elapsed period before licence should be issued
Conviction for using a hand held mobile phone or device while driving	at least 5 years since completion of sentence imposed

The full Assessment of Convictions is attached at Appendix 3.

3.2 The legislation relating to the refusal to grant a driver's licence is contained under the provisions of the LG(MP)A 1976, section 51, whereby at 51.(1) subject to the provisions of this part of this Act, a district council shall, on receipt of an application from any person for the grant of a licence to drive private hire vehicles, grant to that person a driver's licence:

Provided that a district council shall not grant a licence-

- (a) unless they are satisfied that the Applicant S is a fit and proper person to hold a driver's licence: or
- (b) to any person who has not for at least twelve months been and is not at the date of the application for a driver's licence, the holder of a licence granted under Part III of the Act of 1972 (not being a provisional licence) authorising him to drive a motor car.

(2) A district council may attach to the grant of a licence under this section such conditions as they may consider reasonably necessary.

(3) It shall be the duty of a council by which licences are granted in pursuance of this section to enter, in a register maintained by the council for the purpose, the following particulars of each such licence, namely-

- (a) the name of the person to whom it is granted;
- (b) the date on which and the period for which granted; and
- (c) if the licence has a serial number, that number, and to keep the register available at its principal offices for inspection by members of the public during office hours free of charge.

Under S52. Any person aggrieved by –

(1) the refusal of the district council to grant a driver's licence under section 51 of this Act; or
(2) any conditions attached to the grant of a driver's licence;

may appeal to a magistrate's court.

4. 'Fit and Proper'

4.1 The definition of what is a fit and proper person is not defined in law however the generally accepted test is:

- Would you allow your son, daughter, mother, spouse or other person you care about to get into a vehicle with this person alone?

This definition was supported in the judgement by HHJ Silber in the case of *Leeds City Council v Hussain* which surrounds the suspension of a driver:

...'the purpose of the power of suspension is to protect the users of licensed vehicles and those who are driven by them and members of the public. Its purpose is to prevent licences being given or used by those who are not suitable people taking into account their driving record, their driving experience, their sobriety, mental and physical fitness, honesty and that they are people who would not take advantage of their employment to abuse or assault people.'

As Applicant S has the above convictions he is not regarded as a fit and proper person to hold a Private Hire Driver's Licence and the Council made the decision to refuse the application.

Applicant S submitted a written appeal against this decision to the Council on 23 August 2023. A copy is attached at Appendix 4.

5. Legal implications

Decisions in relation to the grant of a licence give rise to the obligations under the Human Rights Act 1998. The Council will therefore ensure that there is a review hearing before the Licensing Sub-Committee. It should be noted that Applicant S has the right to appeal the decision made by the Council to the Magistrates Court if he is aggrieved by the decision of the Sub-Committee.

6. Options

The Sub-Committee is advised that it has the following options when determining this application.

- (i) Uphold the decision to refuse the Private Hire Driver's Licence application
- (ii) Allow the Private Hire Driver's Licence application to progress.

Recommendation

The decision of the Sub Committee is required following proper consideration of the application and any representations made to the Sub Committee.



Assessment of Previous Convictions

Legislation specifically identifies offences involving dishonesty, indecency or violence as a concern when assessing whether an individual is fit and proper. The following reflects this.

Each case will be considered on its own merits and applicants / licensees are entitled to a fair and impartial consideration of their application.

Where a period is given below it will be taken to be a **minimum** in considering whether a licence should be granted or renewed in most cases. This puts passenger safety first while enabling past offenders to sufficiently evidence that they have rehabilitated.

Crimes resulting in death	Never licensed
Exploitation Convicted of a crime involving, related to, or has any connection with abuse, exploitation, use or treatment of another individual irrespective of whether the victim or victims were adults or children. I write regarding your letter dated 18 August 2023 application for a Private Hire Drivers license.

Following my application as above you have told me as per the letter that I am unable to meet the conditions for getting a Private hire Drivers License due to a 6 point conviction.

The 6 points I received for the conviction for using a hand held mobile phone whilst driving were received while I was using a device attached to the dashboard not in my hands to accept a Uber eats job. I paid the fine and took the points not realising that this would impact my Hackney Carriage license.

I was told in a letter from yourselves dated 16/12/22 that you would look at another application in 12 months. Are you now telling me that I cannot reapply for 5 years ?

I would like to appeal against the decision not to grant the license and ask for details of when I can next apply for a license.
