What services are covered by this privacy notice?

Building control – Administration of applications for Building Regulation approval.

Enforcement, Breach of Building Regulations.

Dealing with Dangerous structures.

Street naming and numbering administration.

The handling of Freedom of Information requests. Requests for copies of historical data, such as Completion Certificates, Approval or Rejection Notices.

What personal information do we hold?

The services above may use some or all of the personal information below:

- Names, address and contact details
- Health information (extent of disability for exemption of fees)
- Copies of receipts and delivery notes for product confirmation
- Case file information (stored in council's data base)

We get most of this information from you, but we may also get some of this information about you from other local authorities, and other government agencies,

How do we use your personal information?

We use your information to:

- Deliver the service, or handle your query
- To plan and improve the service we offer
- To detect and prevent unauthorised development, crime or fraud
- Who else might we share your personal information with?

Sometimes we may need to share your information, but we will only do so where it is necessary or required by law. We will only share the minimum information for each circumstance. We may sometimes need to share some of your personal information with:

- Police
- Other Government Agencies including Fire Authority, Anglian Water Services, Environment agency.

- Other Local Authorities.
- Solicitors including information required for Law Enforcement Purposes.
- Other professional bodies such as structural engineers.

Data Processors supporting these activities include:

On occasions we will employ the services of an independent Structural Engineer.
